Notice of 17th AGM, E-Voting for transaction of business & Book Closure

- The Notice of 17" AGM of the Bank to be held on Tuesday, August 10, 2021 at 02:00 p.m., along with the Annual Report for FY 2020-21 comprising of the Directors' Report, Auditors' Report and Audited Financial Statements, have been emailed to the Members of the Bank at their respective e-mail addresses registered with the Depositories/Registrars.
- In view of the continuing COVID-19 pandemic and circulars issued by Ministry of Corporate Affairs in this regard (Circular No. 14/2020 dated 08/04/2020, Circular No.17/2020 dated 13/04/2020, Circular No. 20/2020 dated 05/05/2020 & Circular No. 02/2021 dated 13/01/2021) and by SEBI (Circular No. SEBI/H0/CFD/CMD1/CIR/P/2020/79 dated 12/05/2020 & Circular No. SEBI/H0/CFD/CMD2/CIR/P/2020/79 dated 12/05/2020 & Circular No. SEBI/H0/CFD/CMD2/CIR/P/2021/11 dated 15/01/2021), [hereinafter collectively referred to as "Applicable Circulars"], the AGM will be held exclusively through Video Conterencing (VC) / Other Audio-Visual Means (OAVM).
- Pursuant to the Applicable Circulars, the requirement of sending physical copy of the Notice and Annual Report to the Members has been dispensed with. The dispatch of Notice through electronic mode has been completed on July 16, 2021.
- The Notice is available on the website of the Bank at <u>www.idbibank.in</u>, e-voting website of NSDL at <u>www.evoting.nsdl.com</u> and the same can also be accessed from websites of the Stock Exchanges, i.e. BSE & NSE (<u>www.bseindia.com</u> and <u>www.nseindia.com</u>).
- 5. In terms of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management & Administration) Rules, 2014, as amended, the Items of Business set out in the AGM Notice shall be transacted through electronic voting system. Accordingly, e-voting facility has been provided to the Members who appear in the Books as Members or Beneficial Owners of shares as on August 03, 2021 (End of Day), being the Cut-off date fixed for reckoning the voting rights of Members.
- 6. The date and time of commencement of e-voting is Thursday, August 05, 2021 (09:00 a.m. IST) and the date and time of end of e-voting is Monday, August 09, 2021 (5:00 p.m. IST). The e-voting module shall be disabled by NSDL for voting thereafter. Those Members, who will be present in the AGM through VC / 0AVM facility and have not cast their vote on the Resolutions through remote e-voting and are otherwise not barred from doing so, shall be eligible to vote through e-voting system during the AGM.
- A member who continues to be a member as on the cut-off date, i.e., August 03, 2021, may participate in the AGM even after casting vote through remote e-voting, but shall not be allowed to vote again during the AGM.
- The Register of Members and the Share Transfer Books of the Bank will remain closed from Wednesday, August 04, 2021 to Tuesday, August 10, 2021 (Both days inclusive).
- 9. Persons who have acquired shares during the period from July 09, 2021 (Cut-off date for reckoning the dispatch of AGM Notice) till August 03, 2021 (Cut-off date for reckoning voting rights of members) and are continuing to be Members as on the said cut-off date of August 03, 2021, can exercise their voting right through e-voting during the e-voting period as mentioned in point No. 6 above or during the AGM through VC / OAVM. Such members may obtain the login ID and password from NSDL by sending a request to evoting@nsdl.co.in by giving their shareholding details viz., Name, shares held, Folio no. or DP ID / Client ID no., etc. However, Members who are already registered with NSDL for remote e-voting, can use existing Login ID and passwort for casting their vote electronically.
- Proxy will not be available to members attending AGM through VC as per MCA's directives.
- Information and instructions comprising manner of e-voting by Members holding shares in dematerialized mode, physical mode and for Members who have not registered their email addresses has been provided in the Notice of the AGM.
