IDBI Bank is constantly familiarizing its Directors with the functioning of the Bank including essential areas such as Profile of the Bank/ nature of industry, sub committees of the Board, their roles, responsibilities, details on delegation of powers, financial and other controls and systems, risk, etc. Apart from this, the Independent Directors have also been apprised specifically about their roles, responsibilities and functions (in terms of various statutory/ regulatory provisions) to be discharged by them as members of the Board and various sub-committees of the Board, vide appointment letters issued to them. **Overview of Familiarization Programmes Conducted by the Bank:**

- (i) The Bank regularly acquaints the Board about the updates in the provisions of law stipulated by RBI/SEBI or any other regulatory authority through a separate paper brought in the Board meeting from time to time.
- (ii) The Bank conducts induction programme for its new directors covering areas relating to Governance, finance and accounts, compliance, risk, inter audit, human resource and operations. They are also briefed on their obligations under the various policies/ code and on the terms of reference of the various Committees of the Board of Directors of the Bank.
- (iii) The Directors are in regular contact with the Whole Time Directors and Vertical Heads of the Bank to get a first-hand account of business and regulatory environment and other issues concerning the operations of the Bank.
- (iv) The Bank organises presentations from external agencies for the Directors on the recent matters to keep them abreast of latest business environment.
- (v) The whole time Directors of the Bank have been regularly attending the Meetings organized by various Institutions. Further, the Bank keeps nominating Independent Directors to various programmes on relevant topics for Directors of Banks organized by IICA, IOD, ICAI, CAFRAL, ISRBT, ISB, etc. These programmes have facilitated the Directors to familiarize themselves with emerging developments/challenges facing the Banking sector in general apart from important Corporate Governance aspects impacting their role as Directors in particular.
