

The Question Palette displayed on the right side of screen will show the status of each question using one of the following symbols:



1. Only one question will be displayed on the computer screen at a time
2. Each Question will have 4 alternatives
3. There is 01 mark for each question which will be displayed at the top right hand corner
4. There is 0.25 negative marking for wrong answer
5. The question will be available only in English & Hindi language
6. During examination, screen will continuously display the remaining time at its top right hand corner
7. The candidates may ask the Invigilator their doubts or questions before the commencement of the examination. No queries shall be entertained after the commencement of the examination.
8. Rough Sheet will be provided to the candidates for rough work during the test. All the rough sheets need to be returned to the Invigilator before leaving the examination venue.

About Answering Questions:

1. In order to answer a question, you have to '**Click**' on the option you think is appropriate / correct. The alternative which has been clicked on, will be highlighted and shall be treated as the answer given by you for the question
2. If you do not wish to attempt the question then you should not click on any option for that question and may click '**Next**'
3. You can '**Bookmark**' questions to review before submitting.
4. For saving the response, candidate should mandatorily use "**Left Mouse Click**"
5. You can navigate between questions either by clicking on "Previous", "Next" or by directly clicking on the question numbers which are displayed as attempted/un-attempted/bookmarked in the **Section wise Summary Report**

About Preview and Submission:

1. The answers are saved whenever the candidate navigates e.g. by clicking on **Next/ Previous** button
2. The candidates can make changes in their choice of alternative only before the question paper is **Auto submitted**
3. "**Done**" button will appear only on the last question after **90 minutes** have elapsed from the start time of exam
4. You have to click on "**Done**" button to submit the paper
5. After expiry of **120 minutes** the paper will be **auto submitted** and candidates will not be able to attempt any question or check their answers

Candidate can be debarred /disqualified by the Center-In-Charge for any of the following reasons:

1. Creating a disturbance.
2. Impersonation – Attempting to take the examination for someone else.
3. Giving or receiving assistance of any kind during the examination and communication in any form between candidates or with outsiders or gesticulation or disturbance or attempt to change seat / question paper in the examination hall
4. Attempting to tamper with the operation of the computer or meddling with system.
5. Leaving the test center without the permission from the invigilator.
6. Using prohibited aids, item/s is not allowed, such as: Calculator, Cell Phone, Pieces of Paper, Electronic Diaries, Watch alarm, listening device, recording or photographic devices, or any other unauthorized device.

7. Attempting to take away examination question/s and /or examination response/s (in any format) from the examination center.
8. Failing to follow instructions of invigilator or examination center staff.
9. Manhandling of invigilators or examination center staff.
10. Any suspicious act by the candidate which, as per the opinion of the examination observer has created an impression of unfairness during the examination
11. Resorting to unfair means or trying to influence any person duly authorized to conduct the examination, in any way for examination results shall be considered as a serious offence. The candidate shall be liable to have his/her name removed from the list of candidates for the examination and may also be further dealt with in such manner as it may deem fit.
12. The Chief proctor is authorized to dismiss the candidate/s from the examination center for any misconduct by the candidate/s and his/her decision will be final and binding.
13. Candidates are advised not to indulge in any malpractice, as the entire examination process is monitored and recorded through CCTV.

GENERAL INSTRUCTIONS

1. **Your admission to the examination is strictly provisional.** The mere fact that the call letter has been issued to you does not imply that your candidature has been accepted by the Bank or that the entries made by you in your on-line application for examination have been accepted by the Bank as true and correct. You may please note that the Bank will take up the verification of eligibility conditions i.e. age, educational qualifications, experience and status (i.e. Scheduled Caste/Scheduled Tribe/Other Backward Class/Persons with Benchmark Disability/Ex-Serviceman etc.) with reference to original documents only at the time of interview of candidates who are qualified in the examination on the basis of the marks obtained by them. You may therefore please note that if at any stage, it is found that you do not satisfy the eligibility criteria as given in the Bank's advertisement, or the information furnished by you in the application is incorrect, your candidature is liable to be cancelled forthwith, with such further action as the Bank would like to take.
2. You should ascertain exact location of the venue well in advance of the date of examination
3. You must reach the venue of examination before the gate closing time. You will not be allowed in the venue after the gate closing time.
4. You shall not be permitted to leave the examination hall till the examination over.
5. The Examination will begin after completion of the formalities like checking of Hall ticket, attendance, obtaining signature on the call letter and collection of call letters along with photo identity proof etc. The Bank will not be responsible for any delay or disruption in transport.
6. You must bring the call letter along with the photo identity proof such as PAN Card/Passport/Permanent Driving License/voter's Card with photograph/Bank Passbook with photograph/Photo Identity proof issued by a Gazette Officer on official letterhead /Photo Identity proof issued by a People's Representative on official letterhead/Valid recent Identity Card issued by a recognized College/University/Aadhar/E-Aadhar Card with a photograph /Employee ID in original/Bar Council Identity card with photograph. **Please note that your name as appearing on the call letter (provided by you during the process of registration) should exactly match the name as appearing on the photo identity proof. If there is any mismatch between the name indicated in the Call Letter and Photo Identity Proof you will not be allowed to appear for the exam. The photocopy of photo identity proof should be submitted along with the call letter, to the invigilators in the examination hall failing which he/she will not be permitted to appear for the examination.**
 - Ration Card and Learner's Driving License will NOT be accepted as valid ID proof.
 - In case of candidates who have changed their name will be allowed only if they produce original Gazette notification/their original marriage certificate/affidavit in original.
7. Biometric data (Right thumb impression) and photograph will be captured twice at the examination venue i.e. before the start of exam and after completion of exam. Decision of the Biometric data verification authority with regard to its status (matched or mismatched) shall be final and binding upon the candidates. **Refusal to participate in the process of biometric data capturing / verification on any occasion may lead to cancellation of candidature.** With regards to the same, please note the following:
 - (a) If fingers are coated (stamped ink/mehndi/colored...etc.), ensure to thoroughly wash them so that coating is completely removed before the exam day.
 - (b) If fingers are dirty or dusty, ensure to wash them and dry them before the finger print (biometric) is captured.
 - (c) Ensure fingers of both hands are dry. If fingers are moist, wipe each finger to dry them.
 - (d) If the primary finger (Right thumb) to be captured is injured/damaged, immediately notify the concerned authority in the examination center.(Any failure to observe these points will result in non-admittance for the examination)
8. You should also bring a ball point pen with you to the examination hall.

9. Please note that if you adopt any unfair means or malpractice or commit any misconduct while appearing for the examination, your candidature is liable to be summarily cancelled; more over you may be liable to penal action. **If you are found resorting to any unfair means including giving/receiving help to/from any candidate during the examination you will be disqualified. (You should be vigilant to ensure that no other candidate is able to copy from your answers).** Your responses (answers) will be analyzed with other candidates to detect patterns of similarity of right and wrong answers. If in the analytical procedure adopted in this regard, it is inferred/concluded that the responses have been shared and scores obtained are not genuine/valid, your candidature may be cancelled. Any candidate who is found copying or receiving or giving assistance or engaging in any behavior unbecoming of a candidate will not be considered for assessment. The Bank may take further action against such candidates as deemed fit by it.
10. Instances for providing incorrect information and/or process violation by a candidate detected at any stage of the selection, process will lead to disqualification of the candidate from the selection process and he/she will not be allowed to appear in any recruitment process of the Bank in the future. If such instances go undetected during the current selection process but are detected subsequently, such disqualification will take place with retrospective effect.
11. You should strictly comply with the directions given to you by the examination administrator/invigilator. If any candidate is found disregarding these directions he/she will be liable to be debarred from the examination.
12. Following items will not be allowed inside the examination center:-
Any stationery item like textual material (printed or written), bits of papers, Geometry/Pencil Box, Plastic Pouch, Calculator, Scale, Writing Pad, Pen Drives, Log Table, Electronic Pen/Scanner, Any communication device like Mobile Phone, Bluetooth, Earphones, Microphone, Pager, Health Band etc. Other items like Goggles, Handbags, Hair-pin, Hair-band, Belt, Cap, Any watch/Wrist Watch, Camera, Any metallic item, Any eatable item opened or packed, water bottle, Any other item which could be used for unfair means for hiding communication devices like camera, blue tooth devices etc. All ornaments like Ring, Earrings, Nose-pin, Chain/Necklace, Pendants, Badge, brooch etc. will be thoroughly checked. Any candidate who is found either copying or receiving or giving assistance will be disqualified. **IDBI Bank will NOT be responsible for loss of any candidate belongings.**
13. Anyone found to be disclosing, publishing, reproducing, transmitting, storing or facilitating transmission and storage of examination contents in any form or any information therein in whole or part thereof or by any means verbal or written, electronic or mechanical or taking away the papers supplied in the examination hall or found to be in unauthorized possession of examination content is likely to be prosecuted.
14. **An "Information Handout" booklet giving information about the type of examination you will be taking is available on the Bank's website. Please download the booklet and study it carefully.**
15. You will have to affix your signature and left thumb impression, in the space provided, in the presence of the Invigilator.
16. Guidelines and Declaration Form for PWBD candidates using the services of a Scribe can be downloaded from Bank's website.
17. Please note that since this is a competitive test, mere passing is not adequate. You have to obtain a high rank in the order of merit to get eligibility for interview. You should, therefore, put in your best efforts in the test.
